

**TOWN OF BOW MAR, COLORADO
BOARD OF TRUSTEES DECLARATION
EXTENDING THE DISASTER DECLARATION
DECLARING A PUBLIC HEALTH EMERGENCY RELATED TO COVID-19**

WHEREAS, on March 10, 2020, Governor Jared Polis declared a State of Disaster Emergency in accordance with C.R.S. § 24-33.5-704, as the number of identified COVID-19 cases in Colorado and in the United States increased and announced numerous emergency measures to protect public health and safety; and

WHEREAS, on March 16, 2020, the Bow Mar Board of Trustees declared that a public health emergency and disaster relating to COVID-19 exists within the State of Colorado and within the Town, which declaration was to remain in effect until April 17, 2020; and

WHEREAS, on April 8, 2020, Governor Polis issued Executive Order D 2020 032, which amended and extended Executive Order D 2020 003, as amended by Executive Order D 2020 018, declaring a continued state of disaster emergency due to the presence of COVID19 in Colorado, thereby authorizing continued response activities associated with the disaster emergency; and

WHEREAS, Executive Order D 2020 032 is set to expire thirty (30) days from April 8, 2020, unless modified, rescinded, or extended further by Executive Order; and

WHEREAS, the Town of Bow Mar ("Town") continues to monitor the outbreak of COVID-19 and to take steps to help limit the spread of the disease and prepare for impacts to our community; and

WHEREAS, the Town's declaration of a local disaster and emergency will assist and permit access to local emergency funds, federal and state assistance, and facilitate adjustments to policies, procedures, and ordinances to ensure the public's health and welfare; and

WHEREAS, it appears likely that the pandemic health emergency will extend beyond April 17, 2020, and the Board of Trustees desires to extend its declaration of a public health emergency as a result.

NOW THEREFORE, THE BOARD OF TRUSTEES OF THE TOWN OF BOW MAR, COLORADO DECLARES AS FOLLOWS:

Section 1. Declaration of Public Health Emergency and Disaster Extended. The Board of Trustees hereby extends the declaration of a public health emergency and disaster relating to COVID-19 that it issued on March 16, 2020, and such declaration shall remain in effect until May 30, 2020, unless the Board of Trustees further extends or rescinds the declaration. All other provisions of the March 16 declaration of a public health emergency and disaster shall remain in effect for the duration of this extended declaration. The public shall be notified of this extension through general dissemination to the news media, posting on the Town website, or other means of publicity intended to advise the general public.

Section 2. Effective Date. This extension of a declaration of a public health emergency shall

take effect *nunc pro tunc* as of April 17, 2020.


