## **APPLICATION REQUIREMENTS**

Each application must include *all* the following components:

- 1) Personal Application Letter Your letter should address each of the following:
  - a. Describe your involvement with community service activities including:
    - i. Timeline: Volunteer service must have occurred in the last 12-18 months.
    - ii. Impact: Work should demonstrate real impact from the activity. Examples include number of people served, money raised, how those served benefited from your activities, etc.
    - iii. Community need: Activity must meet a community need or concern. Nominee must be able to articulate their personal contribution to the activity (ex. working with community organizations to continue their work, empowering service recipients to continue their work, etc.).
  - b. Identify a role model, leader or mentor that you admire and explain what you have learned from this person and how you try and emulate those traits in your life.
  - c. Explain how you plan to use this scholarship
- 2) Present two letters of recommendations, one of which *must be* from a resident of Bow Mar. The letters must be relevant to the community services that you highlight in your application. We recommend that you discuss what you'd like to be included in your letter by talking to the person writing your letter. For example, you might want to discuss details of any major projects you worked on including examples of you going above and beyond expectations.

Each page of your application, including letters of recommendation, must have your name clearly marked at the top of each page. You are responsible for ensuring completeness of the application, including inclusion of letters of recommendation. Incomplete applications will not be considered.

#### ELIGIBILITY

Residency: Award nominees must be residents of the Town of Bow Mar.

Service: All volunteer activities must be unpaid and cannot include court-ordered community service.

#### JUDGING

The following criteria are utilized in reviewing and judging nominations:

Community Needs and Solution: Activity must meet a community need or concern. Nominee must have demonstrated substantive personal involvement including specific examples of you going above and beyond expectations.

Impact: How the applicant demonstrated real impact (outputs and outcomes) from the activity.

Time Commitment: Having a strong community service focus that goes into detail about the work you did is better than having a bunch of examples that show you did a couple of hours of work, then moved on to the next organization.

Innovation: Activity should reflect innovative or unique approaches to solving serious social problems.

Entries must be received via U. S. Mail no later than Monday, March 11, 2024, at 5 p.m.

Recipient(s) of the scholarship will be announced at the 2024 Winter Dance (date TBD).
